# **1. WHAT ARE COOKIES AND SIMILAR TECHNOLOGIES?**

Phare Global Markets, Inc., Phare Global Markets, Ltd., and Southeast Empreendimentos, Consultoria Financeira e Participações Ltda. (collectively, "Phare", "we", "us" or "our") use cookies and similar technologies to enhance your experience across our websites and digital platforms. These technologies allow us to collect and store information on the device you use to access our services — including desktops, laptops, tablets, and smartphones.

Cookies are small data files (typically made up of numbers and letters) downloaded to your device when you visit our websites. We may also use similar technologies such as pixel tags or SDKs (software development kits) embedded in mobile applications.

#### We use both:

First-party cookies - set directly by Phare

Third-party cookies – set by partners such as analytics and advertising service providers

## Cookies may be:

Session cookies - removed when you close your browser

Persistent cookies – remain after your browser is closed and allow us to recognize your device on future visits

## 2. WHICH COOKIES DO WE USE AND WHY?

#### A. Strictly Necessary Cookies

These cookies are essential for operating our websites and platforms. They allow you to navigate securely, access restricted areas, and maintain login sessions. Without them, certain core services may not function properly.

These cookies may remember settings such as language or region to improve your browsing experience but are not used to track you for advertising purposes.

#### **B. Performance Cookies**

Performance cookies collect aggregated, anonymous data to help us understand how visitors interact with our sites. This includes tracking page visits, user paths, and technical errors. The insights help us enhance user experience and optimize site performance.
